

## Public License for Criminal Use

By exercising any rights that the artist Alfred Steiner (“**Artist**”) grants in his works of art (each, an “**Artwork**”) under this Public License for Criminal Use (“**License**”), the natural person or other legal entity exercising such rights (“**Criminal**”) agrees to be bound by the terms and conditions of this License.

**1. License Grant.** Subject to the terms and conditions of this License, Artist hereby grants Criminal a worldwide, royalty-free, non-exclusive, non-transferable, non-sublicensable, irrevocable license to reproduce, prepare derivative works based on, distribute, publicly display, publicly perform and digitally transmit any Artwork solely in connection with activity that violates applicable criminal law, excluding laws prohibiting forgery, counterfeiting or similar activities that may reasonably be expected to confound authentication of any original Artwork. Examples of uses permitted under this License include: reproducing and distributing an Artwork on illicit substances or packaging for illicit substances, tattooing an Artwork on an unwilling victim, leaving copies of an Artwork behind as a criminal calling card, etc.

**2. Limitations.** Notwithstanding anything to the contrary contained herein, this License grants no rights to use the Artwork for any purpose that would result in criminal, civil or other liability for Artist. Moral rights, such as the rights of attribution and integrity, are not licensed hereunder, nor are publicity, privacy, or other similar personality rights, but Artist waives and agrees not to assert any such rights that Artist holds to the limited extent necessary to allow Criminal to exercise the rights granted herein. Artist reserves all rights not expressly granted herein.

**3. No Endorsement.** Except as expressly provided herein, nothing in this License constitutes permission to assert or imply that Criminal is, or that Criminal’s use of an Artwork is, connected with, sponsored by or endorsed by Artist.

**4. Attribution Optional.** Criminal may at its option attribute Artwork to Artist by including the following statement in copies of Artwork: “This image is used under Alfred Steiner’s Public License for Criminal Use.” For works of authorship derived from Artwork, Criminal may at its option attribute such work to Artist by including the following statement: “This image is a derivative work based on artwork licensed under Alfred Steiner’s Public License for Criminal Use.”

**5. Disclaimer.** Artist offers the Artwork as-is and as-available, and makes no representation or warranty of any kind concerning the Artwork, whether express, implied, statutory, or otherwise. This includes, without limitation, warranties of title, merchantability, fitness for a particular purpose, non-infringement, or the absence of latent or other defects.

**6. Limitation of Liability.** To the fullest extent permitted under applicable law, in no event will Artist be liable to Criminal on any legal theory (including, without limitation, negligence) or otherwise for any direct, special, indirect, incidental, consequential, punitive, exemplary, or other damages, losses, costs or expenses arising out of this License or use of an Artwork, even if Artist has been advised of the possibility of such damages, losses, costs or expenses.

**7. Indemnity.** Criminal shall indemnify, hold harmless and, at Artist's discretion, defend Artist against any third-party claims arising out of Criminal's use of Artwork or exercise of rights licensed hereunder.

**8. Term and Termination.** This License applies for the term of the applicable copyright, provided, however, that if Criminal fails to comply with this License, then Criminal's rights under this License terminate automatically. Where Criminal's right to use Artwork is terminated under this section, it will be reinstated automatically as of the date the violation is cured or upon express reinstatement by Artist. Artist may also terminate this License at any time, provided that licenses already granted as of the effective date of such termination shall continue to survive in accordance with the terms and conditions hereof. Sections 2, 3 and 5 through 9 shall survive termination of this License.

**9. Miscellaneous.** This License is governed by New York law without reference to any conflicts of law rule that would result in the application of the law of another jurisdiction. Any dispute arising out of this License or Criminal's exercise of rights licensed hereunder shall be settled by binding arbitration in accordance with the Commercial Arbitration Rules then obtaining of the American Arbitration Association. Such arbitration shall be held in New York County, New York and conducted before one arbitrator in the English language. Any award issued as a result of such arbitration shall be binding and enforceable in courts of applicable jurisdiction. This License contains the entire agreement of the parties and there are no other promises or conditions in any other agreement whether oral or written. This License supersedes any prior or contemporaneous written or oral agreements between the parties.
